

FOODBANK LIMESTONE COAST LOTTERY 2018 TERMS AND CONDITIONS

FINAL DRAW

- i. All prizes will be drawn at 2pm on 14 October 2019 at Price Waterhouse Coopers, Level 11/70 Franklin St, Adelaide SA 5000
- ii. The holders of the prize winning tickets will be notified by phone and in writing no later than 4 business days after the draw and published in the Advertiser on 19 October 2019.
- iii. There will be 1,900 tickets in the lottery, comprising of 1,710 tickets at \$100 each and up to 190 bonus tickets.
- iv. A bonus ticket will be allocated to each single entity purchasing a full book of 10 tickets:
 - a. A full book of 10 tickets will be \$1,000
 - b. A bonus ticket will be allocated to the entity purchasing the full book.
- v. Total raffle prize pool of \$80,735.91. For further prize details and inclusions please refer to 'Prize terms and conditions' in this document.
- vi. Proceeds from the sale of tickets will go towards Foodbank SA Limestone Coast building fund and related food relief efforts in the region.

GENERAL TERMS AND CONDITIONS

- 1. The Foodbank SA Limestone Coast Lottery (Lottery) is conducted by Foodbank South Australia Incorporated (Foodbank SA) ABN 70 6733 982 30, of 377A Cross Road Edwardstown SA, 5039 ("we, us or our")
- 2. Foodbank South Australia Incorporated is a registered charity in the state of South Australia.
- 3. These Terms and conditions are the rules which apply to the conduct of the Lottery. By purchasing a ticket or accepting a prize, each ticket holder ("Entrant or you") agrees to these terms and conditions.
- 4. The Lottery is conducted in South Australia under Major Lottery Licence No. M13600 issued by the Office of Business and Consumer Services.



- The Lottery is conducted in accordance with the requirements of the Lottery and Gaming Act 1936 (SA) including the Major Lottery rules as set out in regulation 24 of the Lottery and Gaming Regulations 2008.
- 6. Information on how to enter forms part of the terms and conditions of entry.
- 7. To be eligible to enter, participants must purchase at least one Foodbank Limestone Coast lottery ticket
- 8. Entrants must complete or receive assistance from Foodbank Lottery Seller (who are set out at Term 15 below) in completing their contact details in the section provided.
- 9. Incomplete or incomprehensible entries will be ineligible.
- 10. Complete entries must include at least a first and last name, a full address, email address and a telephone number.
- 11. All tickets purchased will be in the Entrant's name and cannot be on-sold and are non-transferrable. There is no limit to the amount of tickets purchased by one entrant.
- 12. Proceeds from ticket sales from the Lottery benefit Foodbank SA Limestone Coast Branch (Foodbank Mt Gambier).
- 13. Employees and immediate families of officers and employees of Foodbank SA are ineligible to enter. For purposes of this lottery, "immediate family" is defined as the employee and his/her spouse and children.
- 14. Ticket sales open on Monday, 7 of January 2019 and close at 5.00 pm on Monday, 30 September 2019 (unless sold out prior).
- 15. Tickets are available for purchase in person from Foodbank SA and the following locations:
 - a) Foodbank SA Limestone Coast at 23 Cave Road, Mt Gambier
 - a. This may include sales by a Foodbank representative at mobile sites in the Limestone Coast Region.
 - b) Barry Maney Group at 199 Jubilee Highway, Mt Gambier West.
- 16. The total number of tickets sold as part of the lottery will be limited to 1,900 tickets available for purchase, comprising of 1,710 tickets at \$100 each and up to 190 bonus tickets.
- 17. Tickets may only be sold as single tickets at \$100 each or purchase of a book of 10 tickets for \$1,000.
- 18. Book purchases of 10 tickets for \$1,000 made by a single entity will also be allocated a bonus ticket into the draw.
- 19. Each ticket has an equal chance of winning the major prize.
- 20. The lottery will be drawn manually.
- 21. The draw will be made in order of prize value, commencing with the major prize.



- 22. Each ticket can only be drawn once. If a ticket wins a prize it is thereby excluded in any future draws for subsequent prizes.
